**Item 7.01. Regulation FD Disclosure**

On May 16, 2011, Casey's General Stores, Inc. (the "Company") reported April 2011 same-store sales results for stores open for one full year. Same-store sales for prepared food and fountain increased 12.3%, and grocery and other merchandise increased 2.9% in April 2011 compared to April 2010.

Same-store gasoline gallons sold decreased 2.2% in April 2011 compared to April 2010. The gasoline margin was above the Company's fiscal 2011 goal of 13.5 cents per gallon. The average retail price of gasoline sold during April 2011 was \$3.68 per gallon.
