(1) Represents shares of common stock issuable upon settlement of restricted stock units. 50% of the restricted stock units vest in four equal annual installments with the vesting dates beginning March 12, 2013 and ending March 12, 2016. The remaining 50% of the restricted stock units vest in four equal installments on each date in 2013, 2014, 2015 and 2016 when the compensation committee determines if certain performance criteria for each of the fiscal years 2012, 2013, 2014, and 2015 are satisfied, which date shall be not later than the earlier of (i) 30 days following the completion of the annual audited financials for the performance year and (ii) April 30 of the year following the performance year.
