- (1) On June 27, 2011, the reporting person was granted 33,373 shares of restricted stock, subject to the achievement by the Company of performance vesting criteria based on the Company's return on invested capital measured at the end of fiscal 2012. On May 3, 2012, the performance vesting criteria was determined to have been met. In accordance with the Restricted Stock Agreement, the restrictions on one-fifth of the earned shares (6,675 shares) lapsed on the certification date. The restrictions on the remaining shares will lapse ratably on March 31 of 2013, 2014, 2015, and 2016. In connection with the payout of the first one-fifth of the earned restricted stock as described above, 2,433 shares were withheld by the issuer to satisfy income tax withholding requirements.
- (2) In accordance with the issuer's Incentive Plan, this price represents the closing price per share of Common Stock on the vesting date.
