(1) On July 24, 2012, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 2,500 of the 10,000 Performance Shares granted to Mr. Richarz on September 12, 2008. The 2,500 shares will vest on September 12, 2012 (or, in certain circumstances, at the opening of the next following trading window), subject to continuous service through such date.

(2) On July 24, 2012, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 3,600 of the 14,400 Performance Shares granted to Mr. Richarz on September 13, 2010.
