- (1) Grant of restricted stock units. The restricted stock units vest in three equal installments: March 1, 2014; March 1, 2015; and March 1, 2016. Includes the following purchases under the Chemtura Corporation Employee Stock Purchase Plan subsequent to the date of the reporting person's most recent filing on Form 4 providing Table I information: 237 shares on September 28, 2012; 168 shares on December 31, 2012.
- (3) Includes an aggregate of 11 supplemental shares received, subsequent to the date of the reporting person's most recent filing on Form 4 providing Table I information, in connection with the Joint Chapter 11 Plan of Chemtura Corporation, et al., dated August 4, 2010, as amended, which was confirmed by the U.S. Bankruptcy Court for the Southern District of New York on November 3, 2010.
