(1) The number of shares shown represents the time-based restricted stock units (TBRsUs) that vested on May 18, 2011 and were paid on May 16, 2013. These TBRsUs were awarded on March 9, 2011.

(2) Each TBRsU represents a contingent right to receive the value of one share of A. H. Belo Corporation Series A Common Stock. These TBRsUs are valued as of the date of settlement and are paid 60% in shares of A. H. Belo Corporation Series A Common Stock and 40% in cash.

(3) The number of shares shown represents the settlement of the 40% cash portion of TBRsUs that vested and were paid on May 16, 2013. Settlement of the cash portion is, pursuant to SEC guidance, deemed to be a sale of shares to the Company.
