Of the grant of restricted stock, 75% is subject to vesting based on GEO's total shareholder return over a three-year period and 25% is subject to vesting based on certain return on capital employed performance goals being met.
 - (2) The amount of shares has been adjusted to reflect the August 15, 2013 vesting of 5,759 shares of restricted stock and the September 1, 2013 vesting of 576 shares of restricted stock.
