- Represents shares of restricted stock of Sears Holdings Corporation (the "Issuer") granted to Edward S. Lampert pursuant to the Issuer's 2013 Stock Plan, as amended (the "2013 Stock Plan"). On April 1, 2014, the Compensation Committee of the Board of Directors of the Issuer approved awards ("Make-Whole Awards") to holders of outstanding awards, including Mr. Lampert, under the 2013 Stock Plan.
- (1) The Make-Whole Awards were approved to preserve the benefit of the underlying equity awards in connection with the Issuer's distribution (the "Distribution") of all of the issued and outstanding common stock of Lands' End, Inc. ("Lands' End") to the holders of the Issuer's common stock, par value \$0.01 per share ("Shares") as of 5:30 p.m. Eastern time on March 24, 2014, the record date for the Distribution (the "Record Date").
- The Make-Whole Award granted to Mr. Lampert is in the form of Shares and will be issued in equal monthly installments on the last business day of each month through January 31, 2015, except that the monthly installment for March 2014 was issued on April 21, 2014, subject to the same terms that govern the issuance of Shares scheduled to be issued to Mr. Lampert under the 2013 Stock Plan.
- (3) This statement is jointly filed by and on behalf of each of Mr. Lampert, ESL Partners, L.P. ("Partners"), SPE I Partners, LP ("SPE I"), SPE Master I, LP ("SPE Master I"), RBS Partners, L.P. ("RBS"), ESL Institutional Partners, L.P. ("Institutional"), RBS Investment Management, L.L.C. ("RBSIM"), CRK Partners, LLC ("CRK LLC") and ESL Investments, Inc. ("ESL"). Mr. Lampert, Partners, SPE I, SPE Master I, Institutional and CRK LLC are the direct beneficial owners of the securities covered by this statement.
- (4) RBS is the general partner of, and may be deemed to beneficially own securities owned by, Partners, SPE I and SPE Master I. RBSIM is the general partner of, and may be deemed to beneficially own securities owned by, Institutional. ESL is the general partner of RBS, the sole member of CRK LLC and the manager of RBSIM. ESL may be deemed to beneficially own securities owned by RBS, CRK LLC and RBSIM. Mr. Lampert is the Chairman, Chief Executive Officer and Director of, and may be deemed to beneficially own securities owned by, ESL.
