(1) The number of shares shown represents the time-based restricted stock units (TBRUSUs) that vested on May 17, 2012 and were settled on May 15, 2014. These TBRUSUs were awarded on September 12, 2011.

(2) Each TBRUSU represents a contingent right to receive the value of one share of A. H. Belo Corporation Series A Common Stock. These TBRUSUs are valued as of the date of settlement and are paid 60% in shares of A. H. Belo Corporation Series A Common Stock and 40% in cash.

(3) The number of shares shown represents the settlement of the 40% cash portion of TBRUSUs that were settled and paid on May 15, 2014. Settlement of the cash portion is, pursuant to SEC guidance, deemed to be a sale of shares to the Company.

(4) These TBRUSUs were awarded on September 12, 2011.

(5) These TBRUSUs vested 100% on May 17, 2012 and were settled on May 15, 2014.
