- (3) The number of shares shown represents the settlement of the 40% cash portion of TBRUSUs that were settled and paid on May 15, 2014. Settlement of the cash portion is, pursuant to SEC guidance, deemed to be a sale of shares to the Company.
- (4) These TBRUSUs were awarded on September 12, 2011.
- (5) These TBRUSUs vested 100% on May 17, 2012 and were settled on May 15, 2014.
