- (1) Includes 4,160 restricted stock units (RSUs) that vest ratably over five years. Also includes 14,562 RSUs mandatorily deferred by the Company from Mr. McCombe's annual discretionary bonus, plus 3,640 RSUs granted to Mr. McCombe as a Company match on his voluntary bonus deferral. These RSUs will generally vest ratably over four years.
  - (2) Represents the withholding by the Company of a sufficient number of shares of common stock to satisfy Mr. McCombe's tax obligation on the vesting of 5,883 previously reported RSUs.
  - (3) Includes 4,413 total shares of common stock acquired pursuant to the Company's 2004 Employee Stock Purchase Plan. Also includes 1,256 total RSUs acquired pursuant to a dividend reinvestment feature under the Company's 2004 Stock Incentive Plan.
