Accounts are payable only in cash at end of deferral period. This filing is not an admission that Phantom Shares are derivative securities.
- (2) Phantom Stock Units approximate the number of phantom shares of FPL Group, Inc. common stock attributable to phantom units credited to the reporting person's account under the FPL Group, Inc. Deferred Compensation Plan (the Plan).
