On April 30, 2009, Bullion Reef Holdings Ltd. assigned one half of the promissory note to Mr. Ladha and one half of the promissory note to his spouse, Hanifa Ladha.
- These shares are issued in the name of Hanifa Ladha, Mr. Ladha's spouse. Mr. Ladha disclaims beneficial ownership interest in these **(2)**
