Unilever NV also announces that 74,242 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 59,859,903 Unilever NV ordinary shares in treasury, and has 1,654,867,797 Unilever NV ordinary shares in issue (excluding treasury shares).
