Unilever NV announces that on 11 March 2008 it purchased 202,769 Unilever NV ordinary shares (in the form of depository receipts thereof) at prices between euro 20.270 and euro 20.500 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 2,200 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 143,593,417 Unilever NV ordinary shares in treasury, and has 1,571,134,283 Unilever NV ordinary shares in issue (excluding treasury shares).
