On November 30, 2005, the Registrant issued a press release announcing its earnings for the second quarter of fiscal 2006, which ended October 30, 2005. The Registrant reported Pork segment operating profit of \$27.7 million in the second quarter of fiscal 2006. Excluding pretax charges totaling \$16.3 million in connection with the restructuring of the Registrant s east coast pork processing operations, Pork segment operating profits for the quarter would have been \$44 million. The Registrant presented the Pork segment operating profits excluding the plant restructuring charges because it believes it is more meaningful information for the users of the financial statements.
