Electronic Arts Inc. has filed this Current Report on Form 8-K to report that M. Richard Asher, a member of EA's Board of Directors, has established a pre-arranged stock trading plan in accordance with the guidelines of Rule 10b5-1 of the Securities Exchange Act of 1934, as amended, and EA's policies regarding stock transactions by directors, executive officers and other employees. Under Mr. Asher's 10b5-1 plan, which was established on August 29, 2005, up to a total of 60,000 shares of EA common stock held by Mr. Asher may be sold on his behalf at prevailing market prices (but not below predetermined target prices). These sales may take place beginning on December 15, 2005, and continue periodically through June 15, 2008. Transactions under Mr. Asher's 10b5-1 plan will be disclosed publicly through appropriate filings with the Securities and Exchange Commission.
