QVT Financial is also the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account), which holds 139,102 Common Shares. QVT Financial has the power to direct the vote and disposition of the Common Shares held by each of the Fund, QVT Overseas Ltd., QVT Associates LP, QVT Global II LP and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 337,400 Common Shares, consisting of the shares owned by the Fund, QVT Overseas Ltd., QVT Associates LP, QVT Global II LP and the shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of Common Shares reported by QVT Financial.

The reported share amounts for each reporting person reflect amounts held as of August 23, 2006, as adjusted for subsequent transactions through the date hereof.

Each of QVT Financial and QVT Financial GP LLC disclaim beneficial ownership of the Common Shares owned by the Fund, QVT Overseas Ltd., QVT Associates LP, QVT Global II LP and the Common Shares held in the Separate Account.
