(Registrant) to be issued pursuant to the Kulicke and Soffa Industries, Inc. 2007 Equity Plan for Non-Employee Directors (the Plan).

Notwithstanding anything to the contrary, the Registrant is not obligated to indemnify any person or advance expenses with respect to any action, suit or proceeding commenced by the person, other than mandatory counterclaims and affirmative defenses. The Registrant may indemnify its employees and agents, and advance expenses to them, on the same basis as provided in its By-laws for directors and officers, as its board of directors may from time to time determine or authorize.
