As more fully-described in its reports on Form 8-K filed on March 15, 2006 and January 3, 2007 and in Note 5 to the financial statements in its annual report on Form 10-K for the year ended December 31, 2006, Grill Concepts, Inc. (the Company) has a revolving credit facility available to it. The Company from time to time has borrowed under the facility. On April 13, 2007, the Company borrowed \$500,000 under the facility. The borrowing on April 13, 2007 is to supplement working capital while the Company is financing, from funds on hand, construction costs relating to its planned Austin Daily Grill restaurant.
