Explanatory Statement

On May 3, 2001, Chordiant Software, Inc., a Delaware corporation (the Registrant), filed a Registration Statement on Form S-8 (File No. 333-60156) (the Registration Statement), which registered 3,133,871 shares of the Registrant's common stock, par value \$0.001 per share (the Common Stock) reserved for issuance under the 1999 Equity Incentive Plan and the Prime Response 1998 Stock Option/Stock Issuance Plan (collectively, the Plans). This Post-Effective Amendment No. 1 is being filed to remove from registration all remaining authorized shares of Common Stock reserved for issuance under the Plans that have not yet been issued under the Registration Statement.
