On July 6, 2010, MediciNova, Inc. issued a press release announcing that it completed the sale of all of its Auction Rate Securities ( ARS ) held by UBS AG at par value, resulting in net proceeds to MediciNova after payment of its outstanding ARS loan of \$9.5 million, all of which has been invested in money market funds.
