#### **ITEM 8.01 OTHER INFORMATION**

On January 29, 2014, IBERIABANK Corporation (the Company ) disclosed the following:

Based on its capital ratios at December 31, 2013, and including the anticipated impact of the Company s previously announced planned acquisition of Teche Holding Company, the Company currently believes that it would have the ability to generate approximately \$1.2 billion in additional loan growth.

The Company expects to continue experiencing organic loan growth across its markets and across loan types, with greater emphasis on its Florida markets.

Of the remaining balance of \$162 million in the Company s indemnification asset at December 31, 2013, \$24 million is related to the non-single family assets that will lose FDIC loss share coverage within the next 12 months. Of that amount, \$16 million is expected to be collected from the FDIC and \$8 million is expected to be collected from OREO transactions.

The Company s financial operating results for the three months ended December 31, 2013 included \$1.9 million in net covered and non-covered interest income due to loan pool closing events. Of the \$1.9 million, \$0.7 million was from the covered loan portfolio, while the non-covered loan portfolio contributed \$1.2 million.

The Company currently projects its effective tax rate for the twelve month period ending December 31, 2014 to approximate 28%.
