This prospectus supplement updates and supplements the prospectus dated April 8, 2013 of Stereotaxis, Inc., relating to the offering of up to 2,819,345 shares of our common stock, which includes 650,618 shares of our common stock issuable to certain of the selling stockholders upon the exercise of warrants to purchase our common stock, by the selling stockholders named in the prospectus. The shares and the warrants described in the prospectus were issued in connection with that certain Stock and Warrant Purchase Agreement dated as of May 7, 2012 between Stereotaxis and the selling stockholders named in the prospectus. We do not know if any or all of the warrants will be exercised or if any or all of the shares will be resold. We will not receive any proceeds from the sale of the shares, but, assuming exercise of all warrants to which the shares relate, we will receive up to \$2,186,727 in proceeds from the exercise of the warrants prior to those sales.
