**Item 1.01 Entry into a Material Definitive Agreement.**

On October 9, 2015, Monsanto Company ( Monsanto ) entered into uncollared accelerated share repurchase (ASR) agreements with each of Citibank, N.A. ( Citibank ) and JPMorgan Chase Bank, N.A. ( JPMorgan ) to repurchase an aggregate of \$3.0 billion of the Company s common stock. The ASR is part of Monsanto s previously announced share repurchase authorization. Monsanto is funding the ASR with proceeds from the issuance of commercial paper and cash on hand.

Under the terms of the ASR agreements, Monsanto will make a \$1.5 billion payment to each of Citibank and JPMorgan on October 13, 2015 and will receive from each of them on the same day an initial delivery of approximately 14.2 million shares of Monsanto s common stock, based on current market prices. The final number of shares to be repurchased will be based on the volume-weighted average stock price of Monsanto s common stock during the term of the transaction, less a discount and subject to adjustments pursuant to the terms and conditions of the ASR agreements. At settlement, under certain circumstances, each of Citibank and JPMorgan may be required to deliver additional shares of common stock to Monsanto, or under certain circumstances, Monsanto may be required to deliver shares of common stock or to make a cash payment, at its election, to Citibank and JPMorgan. The final settlement of the transactions under the ASR agreements is expected to occur in the next six months.

Each of the ASR agreements contains customary terms for these types of transactions, including, but not limited to, the mechanisms to determine the number of shares or the amount of cash that will be delivered at settlement, the required timing of delivery of the shares, the specific circumstances under which adjustments may be made to the transactions, the specific circumstances under which the transactions may be terminated prior to its scheduled maturity and various acknowledgements, representations and warranties made by Monsanto and Citibank and JPMorgan, as applicable, to one another.

From time to time, Citibank and JPMorgan and/or their affiliates have directly and indirectly engaged, and may engage in the future, in investment and/or commercial banking transactions with Monsanto for which they have received, or may receive, customary compensation, fees and expense reimbursement.

The foregoing description of the ASR agreements does not purport to be complete and is qualified in its entirety by reference to the ASR agreements, copies of which are attached as Exhibits 10.1 and 10.2 and are incorporated herein by reference.
