**Item 8.01 Other Events.**

On May 15, 2018, Banc of California, Inc. (the Company ) announced that its Board of Directors has declared a quarterly cash dividend of \$0.13 per share on its outstanding common stock. The dividend will be payable on July 2, 2018 to stockholders of record as of June 15, 2018.

The Company also announced that the Board has declared a quarterly dividend on its outstanding Series C, D and E Preferred Stock in the amount of \$0.50, \$0.460938 and \$0.4375 per depositary share, respectively, representing an annualized yield of 8.00%, 7.375% and 7.00%, respectively, on the liquidation preference amount (\$25 per depositary share). The dividend will be payable on June 15, 2018 to record holders as of June 1, 2018 of depositary shares relating to the underlying Series C, D and E Preferred Stock.
