On November 27, 2018, Western Digital Corporation (the Company) announced that Mark Long, Chief Financial Officer and Chief Strategy Officer of the Company, and President, Western Digital Capital, will step down from his current role to pursue opportunities as a private equity investor. To ensure a smooth leadership transition, Mr. Long will remain an active member of the Company s leadership team through June 1, 2019. Mr. Long will remain the Chief Financial Officer until his departure or until a permanent successor is appointed. The Company has commenced a comprehensive search for a successor.

The Company and Mr. Long expect to enter into a separation and general release agreement in connection with Mr. Long s departure.
