Mr. Rauner is a principal of (1) GTCR Golder Rauner, L.L.C., the General Partner of GTCR Partners VII, L.P., which is the General Partner of GTCR Fund VII, L.P. Mr. Rauner disclaims beneficial ownership of such shares. Holdings acquired the stock of the issuer by exchanging shares of Coinmach Laundry Corp. and Appliance Warehouse of America, Inc.
