- (1) Grant of restricted stock pursuant to issuer's Stock Incentive Plan consisting of 2,991 shares of restricted stock over a four-year period, 50% after the first two years, 25% after the third year and 25% after the fourth year. The vesting will occur on the last calendar day of the appropriate year.
- (2) On November 10, 2003, the reporting person was granted an option to purchase 1,946 shares of common stock. The option vests in partial installments beginning December 31, 2003, subject to the satisfaction of certain performance criteria. The performance criteria for 467 shares has been met as of March 6, 2007, resulting in the vesting of those shares subject to possible recalculation.
- (3) On May 25, 2004, the reporting person was granted an option to purchase 5,000 shares of common stock. The option vests in partial installments beginning December 31, 2004, subject to the satisfaction of certain performance criteria. The performance criteria for 1,200 shares has been met as of March 6, 2007, resulting in the vesting of those shares subject to possible recalculation.
