  - (1) Award of time-vesting restricted stock pursuant to eLoyalty Corporation 1999 Stock Incentive Plan, subject to continuing employment. The Award was approved by the Board of Directors of the issuer for purposes of 16b-3 and includes a tax withholding feature. 12,334 will vest on 2/29/2008. 30,000 shares have the following vesting schedule: 25% will vest on 2/28/2009 and 6.25% will vest each quarter until fully vested.
  - (2) On 2/21/2008, the reporting person mistakenly reported an Award of time-vesting restricted stock in the amount of 102,334. The correct amount awarded was 42,334. As a result, as of 2/19/2008, the reporting person owned 598,241 shares of common stock.
