*Previous filings for Invesco New York Quality Municipal Securities were made under Morgan Stanley New York Quality Municipal Securities (IQN); the name change resulted from the completion of Invesco Ltd's acquisition of Morgan Stanley's retail asset management business, including Van Kampen Investments, on June 1, 2010.

The Shares reported herein represent UBS AG's combined holdings in multiple series of auction preferred securities of the issuer. These securities are treated herein as one class of securities in accordance with the Auction Rate Securities -- Global Exemptive Relief letter ("Global Relief Letter") issued by the staff of the Securities and Exchange Commission (SEC) on September 22, 2008. UBS AG undertakes to provide, upon request by the SEC staff, the issuer, or a security holder of the issuer, complete information regarding the transaction(s) outlined above as required by the Global Relief Letter.
