 Reflects a grant of Restricted Stock Units ("RSUs") that vests (a) in equal installments on May 1, 2012, 2013, 2014 and 2015, respectively, as long as the Director continues serving on the Board through such vesting dates, (b) upon the Director's death while (1) serving on the Board or (c) upon Director's termination of service from the Board after serving continuously on the Board for at least five years and 360 days have passed since the date of grant. The number of RSUs was determined by dividing \$80,000 by \$48.19, the closing price of the Issuer's Common Stock on the New York Stock Exchange on the day before the grant.
 (2) The 15,000 shares are held by ALG International, LLC in which Mr. Goldstein has a 33.3% interest.
