(1) The shares of the Company's common stock are held in a grantor retained annuity trust, of which the reporting person and his wife are co-trustees. As co-trustees of the grantor retained annuity trust, the reporting person and his wife have voting and dispositive power over the shares held by the trust and are deemed to have beneficial ownership of those shares. On the transaction date, shares in July 2009 Retained Annuity Trust distributed the shares to its beneficiaries, which included the Revocable Trust.

(2) The shares of Common Stock are held by a revocable trust, of which the reporting person and his wife are co-trustees. As co-trustees of the revocable trust, the reporting person and his wife having dispositive power over the shares held by the trust and are deemed to have beneficial ownership of those shares.
