(1) Represents shares withheld to satisfy Mr. Fioravanti's tax withholding obligation with respect to 2,050 shares of common stock issued upon vesting of previously awarded restricted stock units on February 3, 2010. Mr. Fioravanti has retained the remaining 1,421 shares.

Does not include 15,000 shares of common stock issuable upon vesting of restricted stock unit awards, with both a performance-based and time-based vesting schedule, originally granted on February 4, 2008 and amended on September 3, 2010. Does not include 5,500

(2) shares of common stock issuable upon the vesting of time-based restricted stock unit awards granted on June 22, 2009. Does not include 9,950 shares of common stock issuable upon the vesting of time-based restricted stock unit awards granted on February 3, 2010. Does not include 5,000 shares of common stock issuable upon the vesting of performance-based stock unit awards granted on February 2, 2011.

(3) On February 3, 2010 Mr. Fioravanti was awarded 4,100 restricted stock units, which vest 50% on February 3, 2012, and 50% on February 3, 2014. The 2,050 stock units reported herein were 100% converted to common stock on February 3, 2012 upon the vesting of the restricted stock unit award. Accordingly there is no expiration date associated with this security.
