- (1) (TF) On February 29, 2012, the reporting person also received a grant of 437,000 performance stock options and 230,000 performance restricted units. If the performance metric is not met, the grants will be forfeited. If the performance metric is met, the grants will vest ratably over a three-year period from the grant date.
