("Triam Offshore"), Triam Partners Parallel Fund I, L.P. ("Parallel Fund I"), Triam Partners Master Fund (ERISA), L.P. ("Triam ERISA Fund"), Triam Partners Strategic Investment Fund, L.P. ("Strategic Fund") Triam Partners Strategic Investment Fund-A, L.P. ("Strategic Fund-A) and Triam SPV (SUB) V, L.P. ("Triam SPV" and collectively, the "Triam Entities") and as such determines the investment and voting decisions of the Triam Entities with respect to the shares of the Issuer held by them. Mr. Peltz is a member of Triam Fund Management GP, LLC, which is the general partner of Triam Management, and therefore is in a position to determine the investment and voting decisions made by Triam Management on its own behalf and on behalf of the Triam Entities.
 - (3) (FN 2, contd.) Accordingly, Mr. Peltz may be deemed to indirectly beneficially own (as that term is defined in Rule 13d-3 under the Securities Exchange Act of 1934) the shares beneficially owned by Triam Management and the Triam Entities. The Reporting Persons
