 - (2) Investment Fund-A, L.P. ("Strategic Fund-A") and Triam SPV (SUB) V, L.P. ("Triam SPV" and collectively, the "Triam Entities") and as such determines the investment and voting decisions of the Triam Entities with respect to the shares of the Issuer held by them. Mr. Peltz is a member of Triam Fund Management GP, LLC, which is the general partner of Triam Management, and therefore is in a position to determine the investment and voting decisions made by Triam Management on its own behalf and on behalf of the Triam Entities.
