- On December 28, 2012, The Huang 2012 Irrevocable Trust (the "Irrevocable Trust") exchanged cash and debt securities with an aggregate value of \$7,101,440.00 for 584,000 shares of the Company's Common Stock held by the Jen-Hsun & Lori Huang Living Trust, u/a/d May 1, 1995 (the "Trust"). The value of the shares of the Company's Common Stock was the average of the high and low trading price (\$12.16) as reported on the NASDAQ Global Select Market on December 28, 2012.
