(1) Represents restricted shares of Class A common stock of the Company granted on March 1, 2012, one-third of which vested on each of March 1, 2013 and March 1, 2014, and one-third of which will vest on March 1, 2015. As of the date of this filing 5,498 restricted shares of Class A common stock have vested.

(2) On each of November 30, 2012 and January 15, 2014, the Company declared a dividend, payable to all holders of record of Class A common stock on each of December 10, 2012 and January 27, 2014, respectively. Pursuant to the terms of the Company's Omnibus Incentive Compensation Plan and the outstanding grants of restricted shares of Class A common stock, any restricted shares of Class A common stock that were unvested (or vested but not issued) as of the dividend record date were entitled, in lieu of any cash dividend, to a stock dividend for each unvested (or vested but not issued) restricted share of Class A common stock equal to the per-share cash dividend amount divided by the fair market value of a share of Class A common stock on the dividend date. Of the dividend shares issued to the reporting person, 484 restricted shares of Class A common stock remain unvested.

(3) Represents restricted shares of Class A common stock of the Company granted on January 30, 2014, twenty-five percent of which will vest on each of January 30, 2016, January 30, 2017, January 30, 2018 and January 30, 2019.

(4) Represents restricted shares of Class A common stock of the Company granted on March 3, 2014, one-half of which vested immediately and one-half of which will vest on March 3, 2015. As of the date of this filing 3655 restricted shares of Class A common stock have vested.
