On December 16, 2014, Fund IX sold 3,181,335 shares of Common Stock. Following such sale, Fund IX held 11,935,806 shares of Common Stock
- (1) BCI is also the administrative member of Bain Capital Integral Investors, LLC ("Integral"). On December 16, 2014, Integral sold 3,726,069 shares of Common Stock. Following such sale, Integral held 12,752,279 shares of Common Stock.
  - (2) BCI is also the administrative member of BCIP TCVC, LLC ("BCIP TCVC"). On December 16, 2014, BCIP TCVC sold 93,426 shares of Common Stock. Following such sale, BCIP TCVC held 296,156 shares of Common Stock.
