As calculated in accordance with Rule 13d-3 of the Securities Exchange Act of 1934, as amended, (i) Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd. beneficially own 500,000 and 250,000 shares of the Issuer's common stock (common shares), respectively, representing approximately 5.30% and 2.65% of the Common Stock, respectively, and (ii) Sabby Management, LLC and Hal Mintz each beneficially own 750,000 shares of the common shares, representing approximately 7.95% of the common shares. Sabby Management, LLC, a Delaware limited liability company, indirectly owns 750,000 common shares because it serves as the investment manager of Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd., Cayman Islands companies. Mr. Mintz indirectly owns 750,000 common shares in his capacity as manager of Sabby Management, LLC.
