The reporting person may also transfer the phantom stock units into alternative investment accounts in certain other instances if applicable ownership guidelines are satisfied.
- (2) The aggregate of 41,119.51 phantom stock units includes: (a) 267.38 phantom stock units acquired through dividend reinvestment in the Harris Corporation Directors' Deferred Compensation Plans ("Plans") on 9/9/15 and (b) an additional 2.07 phantom stock units due to rounding of previous reports by the Plans' recordkeeper.
