- (1) On September 30, 2016, as a result of receipt of the Requisite Stockholder Approval (defined and described further in the Securities Purchase Agreement dated August 1, 2016 and filed as Exhibit 99.1 to the Current Report on Form 8-K filed by the Issuer on August 2, 2016), each share of Preferred Stock (as defined below) automatically converted into 100 shares of Common Stock, reflecting a conversion price equal to \$1.13 per share.
- (2) The Common Stock is held directly by PNC Investments LLC ("PNC"). Mr. Clark is the sole managing member of PNC.
- (3) The Common Stock is held directly by held by the Paul and Carolyn Clark Revocable Trust of 2009. Mr. Clark is the trustee of the Paul and Carolyn Clark Revocable Trust of 2009.
- (4) These shares of Series C Participating Convertible Preferred Stock ("Preferred Stock") were acquired by PNC in a private placement with the Issuer, which closed on August 8, 2016.
- (5) The Preferred Stock had no expiration date.
- (6) The Preferred Stock was held directly by PNC. Mr. Clark is the sole managing member of PNC.
