Represents a fully-vested stock award for 5,953 shares of common stock in order to provide Mr. Goldberg with the same annual stock grant awarded to non-employee directors for service during fiscal year 2016, pro-rated to reflect Mr. Goldberg's appointment to the Board on August 11, 2016.

(3) Twenty-five percent (25%) of the options vest in four equal installments at end of each fiscal quarter during 2017.

This grant was made in lieu of cash fees for non-employee director service on the Company's board of directors for 2017. Twenty-five percent (25%) of the restricted stock units subject to the award vest at the end of each fiscal quarter during 2017, subject to the reporting person's continuous service as a director.
