Effective January 23, 2018, the Reporting Person resigned as a director of the Issuer.
 - (2) On April 25, 2018, the Reporting Person resigned from her position as the Manager of Philou Ventures, LLC, a Wyoming limited liability company ("Philou"), and as a result, no longer holds voting and dispositive power over the securities of the Issuer held by Philou.
