- (1) Represents the settlement of restricted stock units ("RSUs") that vested on January 1, 2019 through the issuance of shares of common stock.  
 The reporting person is reporting the withholding by the Issuer of an aggregate of 1,072 shares of common stock that vested on January 1, 2019 pursuant to the RSU award referred to in Table II, but that were not issued in order to satisfy the reporting person's tax withholding obligations in connection with the settlement of the RSU award.
