- (1) 2,000 restricted shares were granted effective 2/25/26 and issued from the 2013 Stock Bonus Plan; vesting commences with 500 shares on 2/25/17; 500 shares on 2/25/18; 500 shares on 2/25/19; and 500 shares on 2/25/20.
- (2) Stock price at the close of business on 2/24/16.
- (3) 3,740 shares are held in Mr. Bedner's 401K; 2,247 are held in an account at Computershare; 7,250 shares are restricted stock.
- (4) 10,000 non-qualified stock options were granted on 2/25/16 from the 2013 Stock Option Plan; vesting over a three-year period one-third shall vest; i.e., 3,333 on 2/25/17; 3,333 on 2/25/18; and 3,334 on 2/25/19.
- (5) 90,068 options are outstanding; 58,041 are exercisable; 31,667 are unexercisable. The price varies from \$6.02 to \$12.62.
