 - (1) Includes 20,359 restricted stock units (RSUs) mandatorily deferred by the Company from Mr. Stadler's annual discretionary bonus, plus 5,089 RSUs granted to Mr. Stadler as a Company match on his mandatory bonus deferral. These RSUs will generally vest ratably over four years. Also includes 11,816 RSUs voluntarily deferred by Mr. Stadler from his annual discretionary bonus, plus 2,954 RSUs granted to Mr. Stadler as a Company match on his voluntary bonus deferral. These RSUs will generally be delivered on the third anniversary of grant.
 - (2) Represents the withholding by the Company of a sufficient number of shares of common stock to satisfy Mr. Stadler's tax obligation upon the vesting of 1,941 previously reported RSUs.
