Item 2.02 Results of Operations and Financial Condition.

On January 20, 2009, National Fuel Gas Company (the "Company") issued a press release regarding a significant non-cash charge to write down the value of the oil and natural gas producing properties of Seneca Resources Corporation, the Company's wholly owned exploration and production subsidiary, at December 31, 2008. Significant declines in market prices for crude oil and natural gas between September 30, 2008 and December 31, 2008 require the write-down, which is expected to be in the range of \$100 million to \$120 million after tax. A copy of the press release is furnished as part of this Current Report as Exhibit 99.

Neither the furnishing of the press release as an exhibit to this Current Report nor the inclusion in such press release of any reference to the Company's internet address shall, under any circumstances, be deemed to incorporate the information available at such internet address into this Current Report. The information available at the Company's internet address is not part of this Current Report or any other report filed or furnished by the Company with the Securities and Exchange Commission.

Item 8.01 Other Events.

In connection with the preparation of financial statements required to be included in the Company's Form 10-Q for the quarter ended December 31, 2008, the Company concluded that a material charge for impairment to the oil and natural gas producing properties of Seneca Resources Corporation ("Seneca"), the Company's wholly owned exploration and production subsidiary, is required under generally accepted accounting principles. The decline in market prices for crude oil and natural gas at December 31, 2008 requires the impairment charge.

Seneca uses the full cost method of accounting for determining the book value of its oil and natural gas producing properties. This accounting method requires that Seneca perform a quarterly "ceiling test" to compare the present value of future revenues from its oil and natural gas reserves based on market prices as of the last day of the quarter (the "ceiling") with the book value of those reserves at the balance sheet date. If the book value of the reserves exceeds the ceiling, a non-cash charge must be recorded in order to reduce the book value of the reserves to the calculated ceiling.

At December 31, 2008, spot market prices for crude oil and natural gas that are used to calculate the ceiling had declined significantly to \$41.00 per barrel (Cushing, Oklahoma) and \$5.71 per million British thermal units (Henry Hub), respectively. The book value of Seneca's reserves is expected to exceed the ceiling calculated as of December 31, 2008. Therefore, Seneca will be required to record an after-tax impairment charge, which is expected to be in the range of \$100 million to \$120 million. The impairment charge is not expected to result in future cash expenditures.

types of oil; inability to obtain new customers or retain existing ones; significant changes in competitive factors affecting the Company; changes in laws and regulations to which the Company is subject, including tax, environmental, safety and employment laws and regulations; governmental/regulatory actions, initiatives and proceedings, including those involving acquisitions, financings, rate cases (which address, among other things, allowed rates of return, rate design and retained natural gas), affiliate relationships, industry structure, franchise renewal, and environmental/safety requirements; unanticipated impacts of restructuring initiatives in the natural gas and electric industries; significant changes from expectations in actual capital expenditures and operating expenses and unanticipated project delays or changes in project costs or plans; the nature and projected profitability of pending and potential projects and other investments, and the ability to obtain necessary governmental approvals and permits; ability to successfully identify and finance acquisitions or other investments and ability to operate and integrate existing and any subsequently acquired business or properties; changes in the market price of timber and the impact such changes might have on the types and quantity of timber harvested by the Company; significant changes in tax rates or policies or in rates of inflation or interest; significant changes in the Company's relationship with its employees or contractors and the potential adverse effects if labor disputes, grievances or shortages were to occur; changes in accounting principles or the application of such principles to the Company; the cost and effects of legal and administrative claims against the Company or activist shareholder campaigns to effect changes at the Company; increasing health care costs and the resulting effect on health insurance premiums and on the obligation to provide other post-retirement benefits; or increasing costs of insurance, changes in coverage and the ability to obtain insurance.
