The Class B Common Stock has no expiration date.
- (1) On May 15, 2018, the Issuer granted 12,945 vested shares of Class B Common Stock to the reporting person pursuant to its 2016 Incentive Award Plan, which are subject to contractual restrictions on transfer which expire in four equal annual installments following the grant date.
